

Scholarship Application



The Goodlark Educational Foundation Scholarship is awarded to students who have a significant amount of college or technical school expense that is not being met by other scholarships or financial aid. All applicants must meet the basic admission requirements of the school to which they are applying and must have been a resident of Dickson, Hickman or Humphreys Counties in Tennessee for a minimum of one year prior to application.

High school seniors should return their completed applications (including the documents listed below) to their school counselor by the last school day in March. Other applicants should mail the application and listed documents to The Goodlark Educational Foundation, 445 Hwy 46 South, Suite 29 #213, Dickson, TN 37055. Please include:

1. A copy of the student's completed FAFSA Student Aid Report (SAR) showing the calculated EFC (Expected Family Contribution). The SAR should be at least three pages long.
2. Student's school transcript.
3. Two letters of recommendation.

Applicants will be interviewed before being considered for a scholarship. High school seniors will be interviewed at their schools at a time assigned by the school counselor. Applicants who have not interviewed in the past may be contacted for an interview by the Goodlark office.
